**MOTION FOR POST-CONVICTION
& SENTENCING BAIL**

NOW INTO COURT, through undersigned counsel, comes the Defendant Brian Pope, who, pursuant to Louisiana Code of Criminal Procedure Article 312 (F), moves this Court to set Post-Conviction bail:

1.

In the above captioned case, Brian Pope was sentenced by this Court on June 20th, 2019. The Court sentenced Mr. Pope to a 3-year sentence, all of which was suspended except for one year, which the Court ordered Mr. Pope to serve in the Lafayette Parish Prison. The Court also ordered restitution, Court costs, and community service.

2.

This Court gave Mr. Pope a self-surrender date of June 28th, 2019 at 12 o'clock noon.

3.

Louisiana Code of Criminal Procedure Article 312 (F) reads: "After sentence, and until final Judgment, bail **shall** be allowed if a sentence of 5 years or less is actually imposed."

4.

As this Court is aware, Mr. Pope has been out on bond for the duration of this case. He has never missed a Court date and has violated no conditions of bond.

5.

Based on the above, including the fact that the entitlement to bail after sentence for a sentence of less than 5 years is mandatory, Mr. Pope requests that the Court set a post-conviction bail bond while Mr. Pope pursues his appeal with the Third Circuit Court of Appeal.

The District Attorney's Office opposes this Motion.
