records revealed on November 28, 2017, at approximately 1:44 P.M., Mr. Cherry called his Probation Officer, Charisse Alston. Officer Alston confirmed she spoke to Mr. Cherry via phone and she conducted a home visit with him at 2917 Yukon Street East Tampa, FL 33604, on November 28, 2017, at approximately 4:30 P.M. Officer Alston confirmed the phone number Mr. Cherry called (813-664-5448) was her direct line to her office.

Ms. Bonaparte stated On November 28, 2017, the defendant drove to Lakeland Florida and borrowed her vehicle while she was at work. Ms. Bonaparte advised she saw the defendant was in the company of an unknown, large, bald, black male, who was wearing reading glasses. Ms. Bonaparte was able to identify Chike Tim, via a photograph, as the person she saw with Mr.Cherry. Ms. Bonaparte was shown a photograph of the white Pontiac vehicle seen at the incident scene and she immediately identified the vehicle in the picture as her vehicle. Ms. Bonaparte advised Mr. Cherry told her to report her car stolen but he did not tell her why.

Mr. Tim and Mr. Cherry's cell tower data were obtained, pursuant a court authorized search warrant. Mr. Cherry's cell site locations confirmed he was in Lakeland Florida on November 28, 2017, at approximately 1300 hours, which was consistent with Ms. Bonaparte's statement. Mr. Cherry's cell site locations revealed he was in the area of 2917 Yukon Street East at approximately 4:30 P.M., which was consistent with Officer Alston's statement. Cell site locations confirmed Mr. Tim and Mr. Cherry were in the Clair Mel area, at approximately 1130 hours, which was consistent with Mr. Edward's statement. Cell site locations confirmed Mr. Tim and Mr. Cherry were in the area of the incident scene at the time of the Mr. Tim's death.
